#### Eligibility to contest the election

Any voting member is entitled to nominate for and be elected to the office of General President. Only voting Members may be nominated to office. A financial Voting Member is a member whose subscription is no more than 60 days in arrears as at the date of the opening of nominations.

Prospective candidates should refer to the constitution or contact the Company Secretary for further details relating to requirements to stand for office, and it is recommended that prospective candidates, their proposers and seconders confirm their financial status and other qualifications required before lodging a nomination form.

Statements will be reproduced for AgForce election and media purposes. These statements can be delivered to the nomination email address by the close of nominations.
