Introduction

The NFF's Time to Thrive election priorities chart a basic formula to support the momentum of agriculture and regional Australia.

This election, the NFF is calling on voters to choose parties and candidates that support the investments, innovations and policy proposals identified by regional voters as key to the continued success of their businesses and communities.

This Policy Voting Guide is a summary of where each major party stands on these priorities.

Before you cast your vote, we urge you to take the time to critique the responses received and how they stack up against the NFF's Time To Thrive election asks.

Regional Development Precincts	 Supportive of NFF's precincts approach, but will develop a more coherent framework for regional development once in office. Will reform Regional Development Australia (RDA), with a focus on partnering with local government. 
